**ARTICLES OF INCORPORATION**  
of the  
**TAMARACK & CHESAPEAKE MINING COMPANY.**

Know all men by these presents, that we, Stephen S. Glidden, Frank R. Culbertson, D. M. Brian, Edward Ehrenberg, John Frank, William T. Stoll, W. D. Vincent, Charles R. Brown and Ernest C. Macdonald, all citizens of the United States have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Washington, and to that end do certify as follows:

**Article 1.**

The name of said corporation shall be "The Tamarack & Chesapeake Mining Company."

**Article 2.**

The objects and purposes for which this corporation is organized are as follows, to-wit: To buy, sell, locate own, operate, mine and acquire mining claims, mines, mills, water rights, mill sites flumes, ditches, smelters, stamp mills, concentrators, and other mining machinery, and to do all things incidental to the business of mining; to borrow money for the purpose of expediting and carrying on the business of the company, and to execute mortgages upon the property of the Company to secure the payment thereof, to such amount and upon such terms as the Board of Trustees may think proper; to purchase from the subscribers to the capital stock of such property, both real and personal, rights and privileges, and other things of value as may be useful and necessary to promote the objects for for which said corporation is created, and to receive the same in payment of subscriptions to the capital stock in such amounts as the Board of Trustees may think proper, and to issue full paid up stock therefor. To erect, construct, acquire by purchase or otherwise, operate, equip, maintain, aid in or subscribe toward the construction, maintenance or improvement of mills and factories of every kind and description, works, buildings,

reservoirs, roads, railways, tramways, canals, telegraphs, telephones, rolling stock, machinery and all other things which may be necessary or convenient for any of the purposes of the Company. To procure the Company to be registered in any place or country.

#### Article III.

The amount of the capital stock of this company shall be six hundred thousand dollars, divided into six hundred thousand shares of the par value of one dollar per share.

#### Article IV.

The term for which said corporation is formed is fifty years from and after this date.

#### Article V.

The number of Trustees of said corporation shall be nine, and the names and residences of the trustees who are appointed to manage the concerns of the company for six months from this date and until the election and qualification of their successors, are as follows: Stephen S. Glidden, William T. Stoll, W. D. Vincent, Charles R. Brown and Ernest G. MacDonald, all of the City and County of Spokane, State of Washington; Frank R. Culbertson, D. H. Brien, Edward Ehrenberg, and John Frank, all of the Town of Burke, County of Shoshone, State of Idaho

#### Article VI

The principal place of business of this company shall be at the City of Spokane, County of Spokane, State of Washington, and the company may have such other branch place or places of business as the Board of Trustees may designate.


