ARTICLES OF INCORPORATION APR 21 AM IÙ 18

We, the undersigned natural persons of the age of twenty-one years or more, at least two of whom are citizens of the State of SIADAHO acting as incorporators of a corporation under the Non-Profit Corporation Act, do hereby adopt the following Articles for such corporation.

ARTICLE I

The name of the corporation is: Chapter # 20, Disabled American Veterans Department of IDAHO, Incorporated.

ARTICLE II

The corporation is a non-profit corporation.

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

The purpose for which the corporation is organized is: To uphold the Constitution and laws of the United States, to realize the true American ideals and aims for which those eligible to membership fought, to advance the interest and work for the betterment of all wounded, gassed, injured and disabled veterans, to cooperate with the United States Veteran Administration and all other public and private agencies devoted to the cause of improving and advancing the condition, health and interest of all wounded, gassed, injured and disabled veterans, to stimulate a feeling of mutual devotion, nelpfulness and comradeship among all wounded, gassed, injured and disabled veterans, to serve our comrades, our communities and our country and to encourage in all people that spirit of understanding which will guard against future wars. This corporation is limited to such as will qualify it as an exempt organization under Internal Revenue Section 501 (c) (4). This corporation will not, as a substantial part of its activities carry on propaganda or otherwise attempt to influence legislation This corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

ARTICLE V

This corporation recognizes the National Organization, known as Disabled American Veterans, incorporated by Act of Congress, and affirms its allegiance, and subordination, to said National Organization, its Constitution, Bylaws and all rules, mandates and regulations promulgated pursuant thereto
