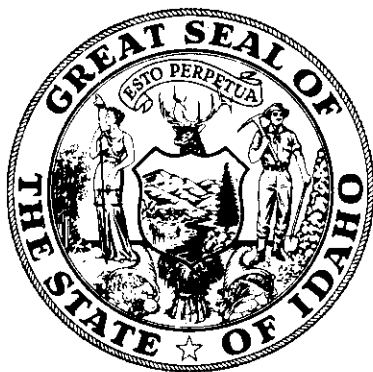

ARTICLES OF INCORPORATION
BANCROFT FULL GOSPEL CHURCH, INC.

KNOW ALL MEN BY THESE PRESENTS:

That I, Buster H. Smith, as pastor of the Bancroft Full Gospel Church, do hereby execute these Articles of Incorporation for the purpose of creating a single director, non-membership corporation as hereinafter set forth:

I.

The name of said corporation shall be Bancroft Full Gospel Church, Inc.

II.

Duration of said corporation shall be perpetual.

III.

Said corporation is formed for the purpose of holding title to property, real or personal, for the benefit of the Bancroft Full Gospel Church, and shall have the powers generally permitted any corporation as presently set forth in the Idaho Code, or as the same may be hereafter amended, insofar as said statutory powers are not inconsistent with the primary purpose of this corporation, as first above set forth.

IV.

Said corporation shall have no shares, and shall have no members.

V.

The pastor of the Bancroft Full Gospel Church shall be the director of said corporation. Upon any change of pastors, the Board of Elders, or other governing body of the said Bancroft Full Gospel Church shall issue to the new pastor a certificate setting forth his appointment as pastor of the church and as director of this corporation.

VI.

The initial registered office of said corporation shall be at Terrace Acres, G-9, 421 North Hooper, Soda Springs, Idaho; and the initial registered agent of said corporation shall be Buster H. Smith, whose address is Terrace Acres, G-9, 421 North Hooper, Soda Springs, Idaho; and whose mailing address is P.O. Box 127, Soda Springs, Idaho 83276.

VII.

The said corporation shall have a single director, and the first director to serve during his term of office as pastor of the Bancroft Full Gospel Church, shall be Buster H. Smith, Terrace Acres, G-9, 421 North Hooper, Soda Springs, Idaho.

VIII.

Said corporation shall be a non-profit corporation, designed only to aid the Bancroft Full Gospel Church with its necessary business matters; and said corporation shall never declare nor pay a dividend, except that in the event of dissolution of both said corporation and the ecclesiastical congregation,

a dissolution dividend may be distributed to those persons who constitute such congregation at the time of dissolution.
