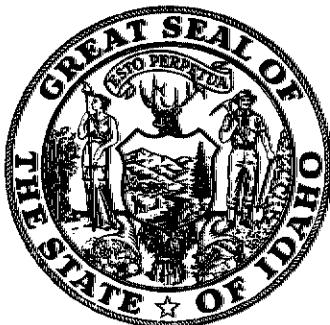

**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
PROFESSIONAL MANUFACTURING, INC.**

Pursuant to the provisions of section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- FIRST:** The name of the corporation is "Professional Manufacturing, Inc."
- SECOND:** The following amendment to the Corporation's Articles of Incorporation was proposed by the board of directors and adopted by the shareholders of the Corporation on April 30, 1996, in the manner prescribed by the Idaho Business Corporation Act:
- Article IV of the Corporation's Articles of Incorporation is hereby amended so that, as amended, the second paragraph of Article IV shall read as follows:
- "Common Stock: 100,000 shares, having One Dollar (\$1.00) par value, amounting in the aggregate to One Hundred Thousand Dollars (\$100,000)."
- THIRD:** The amendment increases the Corporation's stated capital from \$50,000 to \$100,000.
- FOURTH:** At the time of adoption of these Articles of Amendment, the Corporation had 21,000 shares issued and outstanding and entitled to vote on the amendment.
- FIFTH:** The number of shares voted for such amendment was 21,000; and the number of shares voted against such amendment was 0.
- SIXTH:** The original articles of incorporation, as amended to date, are confirmed in all other respects.

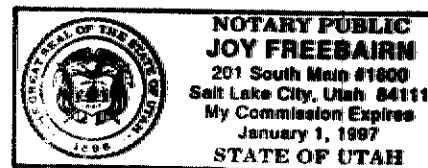
