

ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION

STATE OF IDAHO

Pursuant to the Idaho Business Corporation Act, the sole shareholders and directors of Silver Creek Electric, Inc., hereby adopt the following Articles of Amendment of its Articles of Incorporation.

1. **NAME OF THE CORPORATION.** The name of the corporation prior to the amendment called for herein was Silver Creek Electric, Inc. The new name of the corporation is, and shall hereafter be, D & B, Inc.

2. **ADOPTION OF AMENDMENT.** Paragraph Number 1 of the Articles of Incorporation is amended to change the name of the corporation from Silver Creek Electric, Inc., to D & B, Inc.

3. **DATE OF ADOPTION OF AMENDMENT.** The date of the adoption of the Articles of Amendment by the sole shareholder and director of the corporation is July 3, 1997.

4. **NUMBER OF SHARES OUTSTANDING.** There is only one class of shares in the corporation. The number of shares outstanding in that single class is one million (1,000,000) shares and all of those shares are entitled to vote.


5. **NUMBER OF SHARES VOTING IN FAVOR.** One Million (1,000,000) shares voted in favor of the amendment, and no shares voted in opposition to the amendment. No shares of any class are entitled to vote as a class.

6. **EXCHANGE, CANCELLATION OR RECLASSIFICATION OF SHARES.** The amendment does not provide for an exchange, reclassification or cancellation of issued stock.

7. **EFFECT ON STATED CAPITAL.** The amendment does not effect a change in the amount of stated capital of the corporation.


