

ARTICLES OF DISSOLUTION OF BERG RV CENTER, INC.

These Articles intend the dissolution of Berg RV Center, Inc., and the following information is provided pursuant to Idaho Code Section 30-1-1403.

1. The name of the corporation to be dissolved is Berg RV Center, Inc.

2. Dissolution was authorized by all of the directors and all of the shareholders on the 25 day of August, 1999, with this being the intended effective date of the dissolution.

3. The dissolution was approved by all of the shareholders voting all of their shares of stock in favor of dissolution, to-wit:

(a) The number of votes entitled to be cast on the proposal to dissolve was 500 representing the total number of all of the outstanding shares of stock of said corporation; and

(b) 500 votes were cast in favor of dissolution.

(c) The shareholders intend for the corporation to be dissolved for tax purposes on the date indicated above, and for purposes and for purposes of the records at the office of the Secretary of State on the date of the filing of these Articles Of Dissolution.

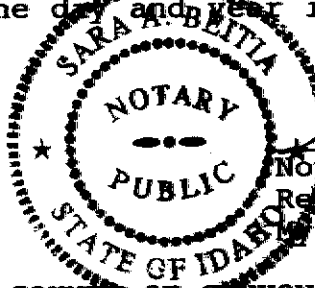

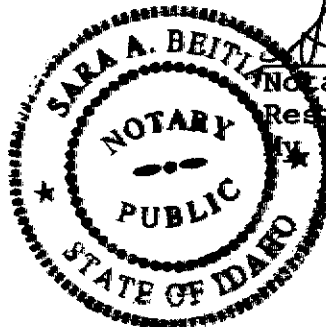
