

6 KNOW ALL BY THESE PRESENTS:

7 The undersigned incorporators, desiring to form a corpora-
8 tion pursuant to the provisions of the Idaho Business Corporation
9 Act, adopt the following articles of incorporation:

10 ARTICLE I

11 The name of this corporation shall be Bestway Carpets, Inc.

12 ARTICLE II

13 The purposes of the corporation are to engage in any or all
14 lawful business for which corporations may be organized under the
15 Idaho Business Corporation Act. To buy, sell, import, export,
16 store, warehouse, distribute, process, manufacture, fabricate,
17 market, and trade in and deal in and with, at wholesale and
18 retail, and in every other manner, floor supplies and materials
19 of every kind and character, and all equipment, goods, and
20 materials of every kind and character used in the construction,
21 building, repair, alteration, and maintenance of floors of every
22 kind and character. Further, to carry on and conduct in all its
23 branches and departments, as principal or agent, the business of
24 retail or wholesale merchants of furniture, fixtures, household
25 appliances and household furnishings of every type and character
26 and all business incidental or in any way connected therewith.

27 Further, to engage in building maintenance, janitorial,
28 window cleaning and watchman service; and to buy, sell and
29 otherwise deal in and with janitorial supplies necessary or

1 useful in such services. To engage in the general business of
2 rug and carpet service and maintenance of all types and descrip-
3 tion, including shampooing, cleaning, repairing, weaving,
4 relaying, dyeing, and demothing, and to carry on and conduct any
5 business incidental thereto including the repair of furniture.

6 ARTICLE III

7 The period of duration of the corporation is perpetual.

8 ARTICLE IV

9 The address of the corporation's initial registered office
10 in the State of Idaho is 605 West Third Street, City of Moscow,
11 County of Latah, State of Idaho 83843. The name of the corpora-
12 tion's initial registered agent at such address is Brent W.
13 DeMeerleer.

14 ARTICLE V

15 The total authorized number of par value shares of stock is
16 5,000. The aggregate par value of the total authorized number of
17 par value shares is FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00).
18 The total authorized number of shares without par value is none.

19 ARTICLE VI

20 Preemptive rights as well as rights to first refusal and
21 buy-sell agreements are referred to in the By-laws.




