

ARTICLES OF INCORPORATION

OF THE STATE OF  
WILLIAM L. SCHULTZ, INC. STATE

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, in order to form a corporation, pursuant to the laws of the State of Idaho, do hereby certify as follows:

ARTICLE I

The name of this corporation shall be WILLIAM L. SCHULTZ, INC.

ARTICLE II

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III

This corporation is formed to carry out any lawful purpose and shall have all the powers allowed by the laws of the State of Idaho.

ARTICLE IV

The capital stock of this corporation shall be in the amount of \$25,000, divided into 25,000 shares of non-assessable common stock of the par value of \$1.00 per share.

ARTICLE V

The principal place of business of this corporation shall be in the City of Boise, County of Ada, State of Idaho, at 7448 Thunder Mountain Drive, Boise, Idaho 83709, which is hereby designated as the address of its registered office. *R. A. William L. Schultz, S.A.*

ARTICLE VI

The name and post office address of the incorporators are William L. Schultz, 7448 Thunder Mountain Drive, Boise, Idaho

83709, and Shirley Schultz, 7448 Thunder Mountain Drive, Boise, Idaho.

#### ARTICLE VII

The management of this corporation shall be vested in a board of not less than two directors and a maximum number as may be fixed by the Bylaws. Other than the first directors of the corporation, the directors shall be elected at the annual meeting of the stockholders to be held at a time and place designated by the Bylaws. 
#### ARTICLE VIII


