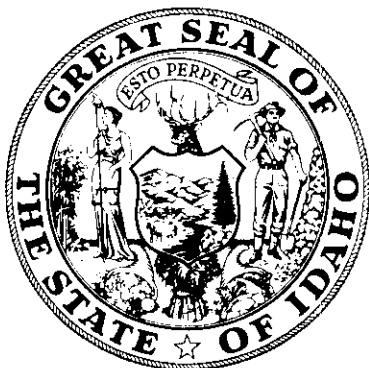

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I

The name of the corporation shall be the Shippers National, Inc.

II

The term for which said corporation shall exist shall be in perpetuity.

III

The address of the initial registered office of this corporation in the state of Idaho shall be 2417 Bank Drive, Suite 8, Boise, Idaho, and the name of the initial registered agent at that address shall be Ernie Dunlap.

IV

The purposes for which this corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

V

The business of this corporation shall be managed and conducted by a board of directors. The number of directors constituting the initial board of directors shall be five (5). Four (4) out of five (5) directors must vote in favor of any proposal in order for it to be deemed approved. The names and addresses of the persons to serve as directors until the first annual meeting of shareholders or until their successors are elected and qualified are:

The aggregate number of shares which this corporation shall have authority to issue shall be 20,000,000 shares of nonassessable common stock at no par value. All shares outstanding shall be entitled to preemptive rights with regard to the issuance of any stock. Seventy percent (70%) of all shares of stock authorized and issued must vote in favor of any proposal in order for it to be deemed approved and seventy percent (70%) of all shares of stock authorized and issued must vote in favor of the election of each director.
