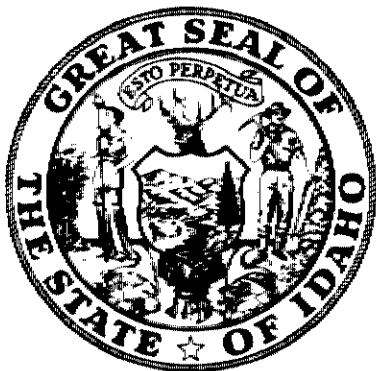

ARTICLES OF INCORPORATION

OF

COEUR d'ALENE CHRISTIAN SCHOOLS, INC.

STATE

We, the undersigned, being six natural persons of full age and citizens of the United States, have this day voluntarily associated ourselves for the purpose of forming a private non-profit corporation under the laws of the State of Idaho, and to that end hereby adopt Articles of Incorporation as follows:

1. N A M E. The name of the corporation is COEUR d'ALENE CHRISTIAN SCHOOLS, INC.

2. DURATION. The period of duration of the corporation shall be perpetual.

3. NON-PROFIT STATUS. The above-named corporation shall be a non-profit corporation formed pursuant to the authority granted in Idaho Code Section 30-300 et. seq.

4. PURPOSES. The corporation is organized for the purpose of operating on a non-profit basis a christian school to provide sound academic training in an environment conducive to the improvement of the moral, mental, social, and physical status of the young people of Coeur d'Alene.

5. MEMBERSHIP CORPORATION. The corporation will be a membership corporation.

6. ELECTION OF DIRECTORS. Directors of the corporation shall be elected in the manner provided by the By-Laws.

7. A D D R E S S. The address of the initial registered office of the corporation shall be Coeur d'Alene Christian Schools, c/o Dalton Garden's Church of Christ, Route 2, Box 173B, Coeur d'Alene, Idaho 83814. The name of the registered agent at that address is Russ Allen.

8. INITIAL DIRECTORS. The number of directors constituting the initial Board of Directors shall be six, and the names and addresses of the persons who are to serve as directors until the first meeting of the corporation or until their successors are elected and qualified are:

10. P O W E R S. The corporation shall have all of the powers granted corporations under the laws of the State of Idaho. However, notwithstanding anything herein to the contrary, the corporation shall exercise only such powers as are in furtherance of the exempt purposes of the organizations set forth in the sub-section of Section 501(c) of the Internal Revenue Code of 1954 under which the corporation chooses to qualify for exemption, as the same now exists, or as it may be amended from time-to-time.

11. DISTRIBUTION OR DISSOLUTION. In the event of the dissolution of the corporation, no member shall be entitled to any distribution or division of its remaining property or its proceeds, and the balance of all money and other property received by the corporation from any source, after the payment of all debts and obligations of the corporation shall be used or distributed exclusively for purposes within the intentment of Section 501(c) of the Internal Revenue Code as the same now exists or as it may be amended from time-to-time.
