

## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF LEADERSHIP BOISE ACADEMY, INC.

The following amendment to the Articles of Incorporation of Leadership Boise Academy, Inc. (the "Corporation") was adopted by the directors of the Corporation.

**FIRST:** The name of the Corporation is:

Leadership Boise Academy, Inc.

**SECOND:** The Articles of Incorporation are amended to read as follows:

1. Article I shall be deleted in its entirety and replaced with the following text:

The name of this corporation shall be Regional Workforce Partnership, Inc.

- 2. Article V, Section (1) shall be deleted in its entirety and replaced with the following text:
  - (1) To conduct education and training programs for the purpose of developing a skilled, diverse and responsive workforce.
- 3. Article VI is amended to delete the name "Greater Boise Chamber of Commerce" and to substitute therefor the name "Boise Metro Chamber of Commerce."

**THIRD:** The foregoing amendment was adopted by the board of directors at a duly called meeting where a quorum was present on May 18, 1999.

**FOURTH:** The Corporation has no members entitled to vote on the amendment.

**FIFTH:** The amendment was approved by a sufficient vote of the board of directors in accordance with the Articles and Bylaws of the Corporation. The Corporation has seven directors. The number of directors voting on the amendment was six. Six directors voted to approve the amendment.

**SIXTH:** The amendment is adopted pursuant to the provisions of Section 30-3-91 of the Idaho Non-Profit Corporation Act.
