## ARTICLES OF INCORPORATION

OF

## SILVER LAKE MARINE, INC.

The undersigned, acting as incorporators of a corporation where the Idaho Business Corporation Act, adopt the following Particles of Incorporation for such Corporation:

Ι

The name of the Corporation is SILVER LAKE MARINE, INC.

II

The period of duration of this Corporation shall be perpetual.

III

The purpose or purposes for which the Corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation's Act.

IV

The aggregate number of shares which the Corporation shall have authority to issue is 2,000 shares, all of which are to have no par value.

v

No stock in the Corporation shall be transferred to a person who is not already a stockholder unless the stock shall have been first offered by a writing for sale to each of the other stockholders of the Corporation at the same price and on the same terms as would govern upon a transfer to a person not a stockholder. The writing shall set forth the price and terms and shall be sent by registered mail to each stockholder at the address listed on the Corporation's books. The right to transfer the stock to a person not a stockholder shall not exist until all existing stockholders refuse the offer made as provided above or until they fail for a period of thirty (30) days after receipt of the written offer to accept the same by compliance with the terms therein set forth. Regulations as to the formalities and procedure to be followed in

effecting the transfer shall be prescribed in the By-Laws of the Corporation.

VI

The address of the initial registered office of the Corporation is 11400 B Center Road, Hayden Lake, Idaho, 83835, and the name of its initial registered agent at such address is Jonathan W. Thompson.

VII

The fiscal year of the corporation shall begin on the 1st day of January, and end on the 31st day of December in each year.

The Corporation shall have no Board of Directors. **A11** corporate powers shall be exercised by or under the authority of, and the business and affairs of the Corporation shall be managed under the direction of the shareholders and officers of the Corporation, as elected by the shareholders, according to procedures outlined in the By-Laws of the Corporation.
