KNOW ALL MEN BY THESE PRESENTS, that we, Lloyd Duncan, J. William Hart, Verla Stroud, Melvin Magnelli, Charles Ireton, Joe Eyre, John Steile III, Charles Marshall, and Ethel Nelson natural persons and residences of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a non-profit cooperative association under the laws of the State of Idaho, Chapter 10, Title 30, and we do hereby certify:

I.

That the name of this corporation is Jerome Bicentennial,

II.

That this corporation shall have perpetual existence.

III.

That the purposes for which this corporation is formed are the following:

- A. This corporation is not formed in contemplation of pecuniary gain and/or profit to the members thereof.
- B. To designate who may be members, and to provide for the method of termination of membership.
- C. To advance the civic development and the economic growth of this community.
- D. This corporation is formed for charitable purposes, the primary charitable purpose of which is the public education and participation in a Bicentennial celebration celebrating the

200th anniversary of the United States of America. This corporation shall conduct such activities as educational programs, pagents, parades, speeches, and other related activities which stress the American heritage and the spirit of man which has been the basis of our country for the past 200 years. The corporation will allow the community of Jerome to explore it's history, explore the history of the American spirit, and at the same time to plan for the future.

- E. To purchase, have, hold, lease, use and take possession of, own and enjoy any real or personal property necessary or incident to, or connected with, the purposes of this corporation; and to sell, lease, alienate and dispose of the same at the pleasure of the corporation.
- of this corporation and, from time to time, without limit as to amount, to draw, make, accept, endorse, guarantee, execute and issue promissory notes, drafts, bills of exchange, warrants, bonds, debentures, and other negotiable or non-negotiable instruments and evidence of indebtedness, and to secure the payment thereof, and of the interest thereon, by mortgage on, or pledge, conveyance, or assignment in trust, of the whole or any part of the assets of the corporation, real, personal or mixed, including contract rights, whether at the time owned or thereafter acquired, and to sell, pledge, or otherwise dispose of such securities or obligations of the corporation.
- G. The above enumerated purposes shall also be considered a statement of powers, and this corporation may do each and every thing suitable or proper for the accomplishment or attainment of the corporation. In addition thereto, the corporation shall have

and may exercise any other or further powers or privileges granted
by the law of the State of Idaho to corporations of this character.
The statements contained in each clause shall be in no way limited
or restricted by reference to, or inference from the terms of any
other clause, but shall be regarded as independent purposes and
powers; and no recitation, or declaration or enumeration of specific
powers or purposes herein enumerated shall be deemed to be exclusive,
and it is hereby expressly declared that all other lawful powers,
not inconsistent herewith, are included herein.

- H. To do any other act, or to enter into any contract that a natural person might lawfully do or enter into. And generally, to transact and carry on any other business and to exercise any other powers which may be necessary, proper or convenient to be carried on or exercised in connection with any of the foregoing purposes or instances thereto.
- I. That the corporation will not carry on activities of a propoganda nature or attempt to influence legislation or will not intervene or participate in any political campaign on behalf of any candidate for public office.
- J. No earnings of the corporation will inure to the benefit of any private shareholder or individual.

IV.

That the principal office for the transaction of business of this corporation is to be located in the City of Jerome, County of Jerome, State of Idaho.

٧.

A. This corporation shall not have any capital stock, but shall admit members into the corporation upon the payment of

a membership fee to be provided for in the By-Laws of this corporation.

New members will not be admitted unless approved by the corporation, subject to a quorum vote of the members present at a membership meeting.

- B. Voting power of the members of this corporation shall be equal. However, each voting member may, by written proxy, designate an agent to vote his rights.
- C. This corporation is one which does not contemplate pecuniary gain or profit to the members thereof.
 - D. Membership in this corporation shall not be assignable.
- E. Dues and assessments may be levied against the members of this corporation by the Board of Directors as provided in the By-Laws.
- F. The members of this corporation shall never be or become liable for the payment of any of the debts or liabilities of the association, and the private property of the stockholders shall not be subject to or liable for the payment of association debts to any extent whatever.

VII.

These Articles of Incorporation may be altered or amended by a two-thirds vote of all voting members of the corporation present
