that we the undersigned have this
day associated ourselves together
for the purpose of incorporating
under the laws of the Territory of
~~Idaho a corporation to be known~~
~~by the corporate name of~~
the Alturas Water Company.
And we hereby certify that the ob-
jects for which this Corporation is
formed are the acquiring of water
rights conveying water through
pipes and other conduits to the
town of Bailey in the county of
Alturas in said Territory and of
selling water to the inhabitants
of said town for domestic uses,
irrigation, manufacturing, the
working of ores, extinguishing fires
and generally for any and all use-
ful and beneficial purposes for
which water may be used. Also
to erect and maintain bathing
establishments at said town of
Bailey and elsewhere in said county.
And to that end to acquire lands
construct reservoirs, lay and main-
tain pipe lines, and generally to
do any and all things necessary
or expedient to be done in carry-
ing out any and all of the aforesaid
purposes and objects of said corpor-

ation.

That its principal place of business shall be at the town of Hailey County of Alturas Territory of Idaho.

That the time of its existence shall be fifty years.

That the amount of the Capital Stock of said Corporation shall be Fifty Thousand (\$50,000) Dollars divided into Fifty thousand (50000) shares of the par value of One Dollar each.

That the number of Trustees who shall manage the affairs and concerns of the company for the first three months is seven and that the names of such trustees are
