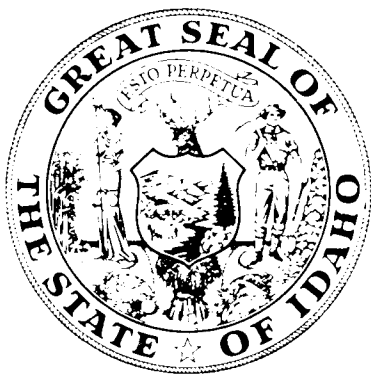


THIRD: All notices required by Idaho Code §30-1-87 have been given.

FOURTH: All debts, obligations and liabilities of the corporation have been paid and discharged, or adequate provision has been made therefor.


FIFTH: All of the remaining property and assets of the corporation have been distributed among the shareholders in proportion to their respective rights and interests.


