ARTICLES OF INCORPORATION

OF

WILLIAM DAVIS, INC.

PROVISIONS OF THE ARTICLES:

That we, the undersigned, being legal persons of full age and mind, do hereby certify that we have adopted the following articles of incorporation for the purposes hereinafter stated, present to the public an incorporation of a public utility, and hereby certify as follows:

1. The name of the corporation is "WILLIAM DAVIS, INC."
2. The objects of the business of the corporation are television receiving sets, radio receiving sets, electrical appliances, television appliances, and appliances for the production of programs on such television sets, and in connection therewith to obtain, use, and exploit franchises, licenses, and other privileges which may be granted in the operation of the business;
3. In connection, erection, hire, and use of a plant, building, and apparatus and machinery required for the operation of the business.
4. The commencement of the life of this corporation shall be the date of the issuance of a certificate of incorporation by the Secretary of State of the State of Idaho, and the duration of the life of this corporation shall be fifty years.
5. The location of the principal office of the registered office of the corporation shall be at Boise, Idaho, County, Idaho.
6. The total authorized number of shares of stock is 10,000 shares of the par value of \$1.00 per share. No other stock of any type of shares shall be issued or sold and the same shall be subject to the exercise of the right.
