1. Name. The name of the corporation is Heat Energy & Associated Y OF STATE Technologies, Inc. STATE OF IDAHO

2. Terms of Classes or Series of Shares Determined by Board. The board of directors may determine, in whole or in part, the preferences, limitations, and relative rights, within the limits of section 30-1-601, Idaho Code, of (a) any class of shares before the issuance of any shares of that class or (b) one (1) or more series within a class before the issuance of any shares of that series. Each series must have preferences, limitations, and relative rights identical with those of other shares of the same series and, except to the extent otherwise provided in the description of the series, with those of other series of the same class. Before issuing any shares of a class or series created under this section, the corporation shall deliver to the secretary of state for filing articles of amendment, which are effective without shareholder action that set forth the information required by section 30-1-602, Idaho Code. Authorized common shares. The aggregate number of voting common shares the corporation is authorized to issue shall be 100,000,000,

3. Registered office and agent. The registered office of the corporation is 508 N. 13th Street, Boise, ID 83702 and its registered agent at that address is Michael R. Jones.

4. Incorporator. The name of the incorporator is Michael R. Jones and the incorporator's address is 508 N. 13th Street, Boise, ID 83702.

5. Corporate Purpose. The purpose for which the corporation is organized is the transaction of any lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

6. Indemnification. The corporation shall indemnify the directors and officers of the corporation to the fullest extent permitted by the Idaho Business Corporation Act, as the same exists or may hereafter by amended (but, in the case of any such amendment, only to the extent that such amendment permits the corporation to provide broader indemnification rights than the Idaho Business Corporation Act permitted the corporation to provide prior to such amendment).

7. Limitation of Liability. No director or officer shall be liable to the corporation or its stockholders for monetary damages for breach of fiduciary duty except liability for: (i) the amount of a financial benefit received by a director to which he is not entitled; (ii) an intentional infliction of harm on the corporation or the shareholders; (iii) a violation of § 30-1-833, Idaho Code; or (iv) an intentional violation of criminal law.
