### ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned increptorator being of the age of eighteen years or more, desiring to organize a corporation under the laws of the State of Idaho, do hereby make, sign and verify these Articles of Incorporation.

#### ARTICLE I

The name of the corporation is JON E. HEITZMAN, O.D., P.A.

#### ARTICLE II

The period of its duration is perpetual.
