KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned incorporators,
of the STATE OF IDAHO, being of the age of eighteen years or more, desiring to organize a corporation under the laws
of the State of Idaho, do hereby make, sign and verify these Articles of Incorporation.

ARTICLE I

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purposes for which the corporation is organized are as follows:

- (a) To undertake any business activities of any kind or nature for which businesses may be lawfully incorporated under the laws of the State of Idaho;
- (b) To do all other things necessary or incidental to the foregoing business purposes.

ARTICLE IV

The corporation is authorized to issue one class of shares, in a total amount of 1000 shares. The stock shall bear no par value. Shares of stock of this corporation shall not be transferred or sold until said sale shall be approved by the Board of Directors of this corporation, in accordance with the duly adopted By-Laws of this corporation.

The capital stock of this corporation, after the amount of the subscription price or par value has been paid in, shall not be subject to assessment and no paid up stock and no stock issued as fully paid shall be assessed or be assessable.

ARTICLE V
