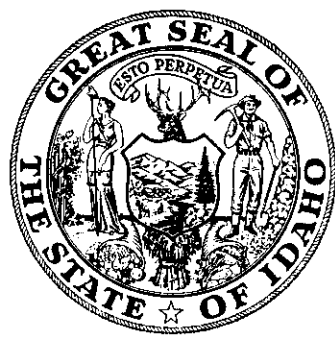
CERTIFICATE OF AMENDMENT OF

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned , acting as President of a corporation under the Idaho Business Corporation Act, amend the following Articles of Incorporation for such corporation:

AMENDED ARTICLE I

The name of the corporation shall be "Idaho Door Supply and Service, Inc.".

ARTICLE II

The purpose of this Corporation is to engage in any lawful act or activity for which a Corporation may be organized under the Law other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the Idaho Corporation Code.

ARTICLE III

The corporation shall have perpetual existence.


ARTICLE IV


