ARTICLES OF INCORPORATION

of

STATE

TREASURE VALLEY AERIE 3803 FRATERNAL ORDER OF EAGLES, *INC.*

We, the undersigned persons of the age of 19 years or more, at least the majority of whom are residents of the State of Idaho and citizens of the United States, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the statutes of the State of Idaho.

ARTICLE ONE

The name of the corporation is Treasure Valley Aerie 3803 Fraternal Order of Eagles, *INC. as per Sherree McCallum*

ARTICLE TWO

This corporation shall be a nonprofit corporation.

ARTICLE THREE

The period of duration of the corporation shall be perpetual.

ARTICLE FOUR

Corporate purposes:

To effect the association of American citizens of not less than 19 years of age and of good moral character for fraternal purposes, and for their mutual benefit and social betterment; to effect the establishment and operation of club facilities for the exclusive pleasure, recreation, and entertainment of members of the club and eligible guests; to purchase, lease, hold, sell, develop, erect, build, mortgage, deed in trust, convey, or otherwise acquire and dispose of real and personal property, and to maintain and operate same for the use and equipment of all the members of the club, subject to such rules, regulations, and restrictions as set forth in the bylaws of this corporation and as determined by action of the board of directors in regular meeting; to do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes or attainment of any of the objects heretofore set out or mentioned, either alone or in association with other individuals, corporations, or partnerships, including but not limited to, the county, state, federal, and municipal bodies and authorities; and in general, to do and perform such things and acts and

1 transact such business in connection with the foregoing objects not inconsistent
2 with the general laws of this land or the objects and aims of the Fraternal Order
3 of Eagles.

4 ARTICLE FIVE

5 The corporation shall be nonstock, and no dividends or pecuniary profits
6 shall be declared or paid to the members thereof.

7 ARTICLE SIX

8 The street address of its initial registered office and the name of its

11 ARTICLE SEVEN

12 The number of directors constituting the initial board of directors shall


