Cardiogrip IPH, Inc., an Idaho corporation ("CardioGrip") and Zona Health, Inc., an Idaho corporation ("Zona Health"), DO HEREBY CERTIFY as follows:


1. The constituent entities in the merger (the "Merger") are CardioGrip, with its principal place of business at 12554 W. Bridger Street, Suite 108, Boise, Idaho and Zona Health, with its principal place of business at 12554 W. Bridger Street, Suite 108, Boise, Idaho.
2. A Plan of Merger (the "Merger Plan") has been duly authorized and approved by the Shareholders and Directors of CardioGrip in accordance with Chapter 18, Part 2, Title 30 of the Idaho Entity Transactions Act ("IETA"). The Merger Plan has been duly authorized and approved by the Shareholders and Directors of Zona Health in accordance with Chapter 18, Part 2, Title 30 of the IETA.
3. Pursuant to the Merger Plan and in accordance with IETA, CardioGrip is being merged with and into Zona Health, with Zona Health being the surviving corporation in the Merger (the "Surviving Entity").
4. The address of the Surviving Entity where copies of process may be sent by the Idaho Secretary of State is 12554 W. Bridger Street, Suite 108, Boise, Idaho, 83713.
5. The Merger Plan was submitted to and approved by the Board of Directors of Zona Health on February 9, 2015, and a majority of the shareholders of Zona Health on February 23, 2015.



7. The Merger is effective as of February 23, 2015, upon filing an executed version of this Statement of Merger with the Idaho Secretary of State pursuant to IETA (the "*Effective Time*").
8. At the Effective Time, the Third Amended and Restated Articles of Incorporation of Zona Health as in effect immediately prior to the Effective Time, shall be the Articles of Incorporation of the Surviving Corporation.
