KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, to form a corporation for the purposes hereinafter stated, adopt the following Articles of Incorporation for such corporation:

ARTICLE 1.

NAME

The name of the corporation is the **DOUBLE R MINISTRIES, INC.**

ARTICLE 2.

NON-PROFIT CORPORATION

The corporation is a non-profit corporation.

ARTICLE 3.

PERIOD OF DURATION

The period of its duration is perpetual.

ARTICLE 4.

CORPORATE PURPOSES

The purpose or purposes for which the corporation is organized are:

1. To engage in any and all religious, benevolent, charitable, missionary, social and other services and activities as may be authorized by its Board of Directors and/or its Members (including but not limited to, the holding and conducting of religious meetings and worship services and the religious training and edification of those who may attend such meetings and services); and to do all things and to own all properties which may be incidental, necessary, conducive, expedient, proper and/or suitable for the attainment and accomplishment of any one or more of the purposes enumerated or which shall, at any time, appear to be conducive or expedient for the benefit of the corporation;
2. To worship God, and to promote Christian life and character through worship, instruction, evangelism, fellowship and service;
3. To raise money by donation, subscription, or otherwise for any of its purposes;
4. To grant to its Members any and all rights not prohibited by law;
5. To conduct the business and temporal affairs of the corporation and to own all properties and to do all things incidental and/or necessary thereto;
6. To do and to perform any and all acts and everything necessary, suitable

and/or proper to perform any and all things within the scope, power and authority of a religious corporation and related thereto; and,

7. Any and all purposes and acts which are not repugnant to law.

ARTICLE 5.

MEMBERSHIP

The corporation shall have no capital stock and shall be strictly and wholly a membership organization. Any member of the Body of Christ may become a Member of the corporation, as provided in the By-laws, upon being certified by one or more of the Members.

ARTICLE 6.

CHURCH BOARD

1. The affairs of the corporation shall be managed by a Church Board; which board shall be governed by these Articles of Incorporation and by such By-Laws as the corporation may hereafter, from time to time, adopt.

2. The number of Members constituting the initial Church Board of the corporation shall be ten (10); and, may be increased or decreased from time to time by amendment of the By-Laws in any manner not prohibited by law. ARTICLE 9.

AMENDMENTS

ARTICLES OF INCORPORATION: These Articles of Incorporation may be amended by at least a majority vote of the Members present at any Annual Meeting of the Membership of the corporation, providing that notice thereof has been given according to law and that a quorum is present at the meeting.

BY-LAWS: The power to alter, amend or repeal the By-Laws or to adopt new By-Laws of the corporation is delegated by the Membership of the corporation to the Church Board; PROVIDED, HOWEVER, that By-Laws so altered, amended, repealed or adopted by the Church Board shall be subject to change or repeal by the affirmative vote of a majority of the Membership entitled vote at any Annual Meeting of Members of the corporation.

ARTICLE 10.

Disposition of Corporate Assets Upon Dissolution

Upon Dissolution of the Corporation, all of the corporate assets are to be contributed for no compensation to the Louvier Ministries, Inc. PO Box 1124, Chatsworth, California, so long as the ministry is at the time of such contribution, a religious non-profit organization entitled to exemption under Section 501(C)(3) of the Internal Revenue Code and in the alternative if such organization does not exist or is not so exempt, then to an organization serving the Body of Christ which is listed by the United States Government as a religious non-profit organization entitled to exemption under Section 501(C)(3) of the Internal Revenue Code, such organization having received a letter of award and having been listed by the Federal Government as such.

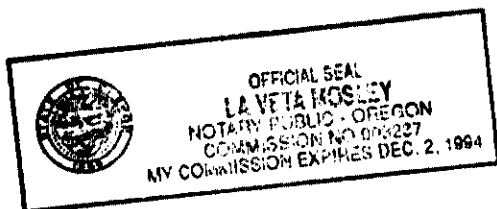
