CONTINUED ARTICLES OF INCORPORATION**

Article 6: The authorized capital stock of the corporation shall be \$500.00, divided into 50,000 shares of common stock of the par value of \$0.01 per share. All of the stock shall be of the same class, have the same powers and voting rights and shall not be assessable for any purpose whatsoever.

Article 7: All corporation powers shall be exercised by and the business and the affairs of the corporation shall be managed under the direction of a Board of Directors consisting of no less than two (2) directors. The qualifications, term of office, manner of electing directors, number of directors to be elected, time, place, and manner of calling meetings, and the powers and duties of the directors shall be prescribed by the Bylaws. The names and office addresses of the persons who are to serve as directors until the first annual meeting of the stockholders or until their successors are elected and qualified are:

Article 8: The purpose for which said corporation is organized is to do all things authorized by the Idaho Business Corporations Act and, specifically, to do all things for and with oil separation equipment.

Article 9: The power to repeal and amend the Bylaws and adopt new Bylaws is hereby conferred upon the directors, as well as upon the shareholders, to be exercised by such vote of the directors or of the allotted shares as the case may be; provided, however, not less than a majority thereof as may be fixed by the Bylaws. The Board of Directors may from time to time distribute to its shareholders, out of capital surplus of the corporation, a portion of its assets in cash or in property.

Article 10: No contract or other transaction between the corporation or any other corporation, whether or not a majority of the shares of the capital stock of such other corporation is owned by the corporation, and no act of the corporation shall in any way be affected or invalidated by the fact that any of the directors of the corporation are pecuniarily or otherwise interested in, or are directors or officers of such other corporation; any director individually may be a party to or may be pecuniarily or otherwise interested in any contract or transaction of the corporation and any director of the corporation who is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the company which shall authorize such contract or transaction and may vote thereon to authorize such contract or transaction with like force and effect as if he were not such director or officer of such other corporation and not so interested.
