ARTICLES OF INCORPORATION OF ED

- KNOW ALL MEN BY THESE PRESENTS: '82 JAN 22 PM 4 39 That we, the undersigned SEARELISE was TASEay voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of IDAHC , and we do hereby certify as follows:

ARTICLE I

The name of the corporation is: Idaho Solar Products, Inc.

ARTICLE II

The specific business in which the corporation is primarily to engage in is in the retail and wholesale of solar rpous and water heating systems and energy related components.

ARTICLE 111

- 1) The general purpose for which this corporation is formed is to install, Fetail and wholesale sclar space and water heating systems and related components.
- 2) To own, operate, maintain, equip, improve, alter, manage, and otherwise deal with, use and enjoy, to invent, design, develop, assemble, build, construct, fabricate, manufacture, buy, import, lease as lessee, and otherwise acquire, to mortgage, deed in trust, pledge and otherwise encumber, and to sell, by retail or wholesale, export, lease as lessor, and every sort, nature and description.
- To construct, lease, rent or otherwise acquire and maintain all facilities necessary or convenient in the prosecution of the business of this corporation.
- 4) To enter into, make, perform and carry out contracts of every kind which may be necessary or convenient for the business of this corporation, with any person, firm, corporation, private, public or municipal body politic, any state, territory, or municipality of the United States, or any foreign government, colony or body politic.

- hold, mortgage, pledge, sell, assign, transfer, exchange or otherwise, wise dispose of shares of the stock of, or voting trust certificates for shares of the stock of, or any bonds or other securities, evidence of indebtedness or obligations created by any other cornoration or corporations organized under the laws of the State of IDAHO or any other state, or any country, nation or government, and to pay therefore, in whole or in part, with cash or other property, or with shares, bonds or other obligations of this corporation, and while the owner or holder of any such shares, gations of such corporation or corporations, to possess and exercise in respect thereof all the rights, powers, and priviliges of ownership, including the right to vote thereon and to consent in respect thereof for any and all purposes.

- 7) To promote, aid and assist, financially or otherwise, corporations, co-partnerships, joint stock companies, syndicates, trustees, associations and individuals to the extent legally per-missible to a corporation organized under the laws of the State of California, and to a like extent endorse and underwrite the shares, bonds, debentures, notes, securities or other obligations or undertakings of any corporation, co-partnership, joint venture stock company, association, syndicate, trustee or individual and to upon bonds, notes, debentures or other obligations of, or the performance of any contracts by any corporation, co-partnership, joint stock company, association, syndicate, trustee or individual.
- lease or otherwise acquire, and to maintain, protect, hold, use, own, exercise, develop, operate, and introduce, and to sell, grant licenses or other rights in respect of, assign, trade names, patent, patent rights, copyrights and distinctive marks and rights analogous thereto, and inventions, improvements, processes, formulate and the with, or secured or received under letters patent of the United capable of use in connection with the business of this corporation, in respect of any such trademarks, trade names, patents, patent and the like.
- 9) To acquire all or any part of the good will, rights, assets and business of any person, firm, association or corporation heretofore or hereafter engaged in any business, in whole or part, similar to the business of this corporation, and to hold, utilize and in any manner dispose of the whole, or any part of the business

- otherwise acquire, and to own, hold, develop, operate, sell, assign, transfer, convey, exchange, lease as lessor, mortgage, pledge or otherwise dispose of and encumber real and personal property of every class and description, and rights and privileges therein, in the State of IDAHO, and in any and all other states, territories, districts, possessions, colonies, and dependencies of the United States of America, and in any or all foreign countries which may be suitable or convenient in connection with the business of this corporation.

- 14) To guarantee the payment of dividends upon, or any sinking fund payments in respect of, any shares, or the payment on the principal of, or interest on, or sinking payments in respect of any bonds or other securities or evidences of indebtedness, or the performance of any contract of any other corporation, or corporations insofar as, and to the extent that a guaranty in respect thereof by this corporation may be permitted by law.

- 15) In connection with the purchase, lease or other acquisition by this corporation of any property, of whatsoever nature, to pay therefor in cash or property, or to issue in exchange therefore shares, bonds, or other securities or evidences of indebtedness of this corporation, and to assume in connection with any such acquisition of liabilities of any firm, association, or corporation.
- 16) To carry on its business, and for the purpose of attaining or furthering any of its objects or purposes, to make and perform such contracts of any kind and description, to do such acts and things, and to exercise any and all such powers as a natural person could lawfully make, perform, do or exercise, provided that the same be not inconsistent with the laws of the State of *TDAHC*.
- 17) To carry out all or part of the foregoing objects and purposes as principal, agent, contractor, or otherwise either alone or in conjunction with any person, firm, association or other corporation, and in any part of the world, and in carrying on its business, and for the purpose of attaining or furthering any kind of its objects or purposes, to make and perform such contracts of any kind and description, to do such acts and things, and to exercise any and all such powers, as a natural person could lawfully make, perform, do or exercise provided that the same be not inconsistent with the laws of the State of TDAHO.
- 18) To conduct its business in all or any of its branches in the State of **TDAHO**, and in any or all other states, territories, possessions, colonies, and dependencies of the United States of America, and in the District of Columbia, and in any and all foreign countries, and to have one or more offices within the and outside of the State of **IDAHO**.
- 19) To do any and all things necessary, suitable, convenient or proper for, in connection with, or incidental to, the accomplishments of any of the purposes or attainment of any one or more of the objects herein enumerated, or designed, directly or indirectly to promote the interests of this corporation, or to enhance the value of any of its properties and, in general, to do any and all things and exercise any and all powers which it may now or hereafter be lawful for the corporation to do or to exercise under the laws of the State of IDAHO that may now or hereafter be applicable to this corporation.
- time to time, and at any time, to do one or more of the acts and things herein set forth, and to have all the powers, rights, and privileges now or hereafter conferred by the laws of the State of California authorizing the formation of corporations; provided, however, that nothing herein contained shall be deemed to authorize this corporation to construct, hold, maintain or operate within the State of IDAHO urban railroads, or interurban or street railways, or telephone lines, or to carry on within said state the business of a gas, electric, steam heat or power company, or to carry on within said state any other public unilities business.

The object, purposes and powers specified in each of the clauses or paragraphs in these Articles shall be regarded as independent objects, purposes and powers.

ARTICLE IV
