The undersigned, in order to form a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

Article 1: The name of the corporation shall be:

Wilson Elementary Parent Teacher Organization, INC.

Article 2: The purpose for which the corporation is organized is:

The Corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code; including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the afore mentioned section 501(c)(3) of the Internal Revenue Code. Specifically, the organization exists solely to serve and supplement Wilson Elementary School through fundraisers, sales, funds, and/or merchandise collected from donors or grantors, and time or services donated from local persons. In pursuance of these purposes it shall have the powers to carry on any business or other activity which may be lawfully conducted by a corporation organized under the Idaho State Non-profit Corporations Act, whether or not related to the foregoing purposes, and to do all things necessary, proper and consistent with maintaining tax exempt status under section 501(c)(3).
