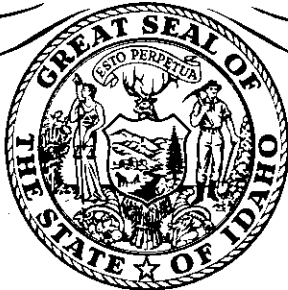

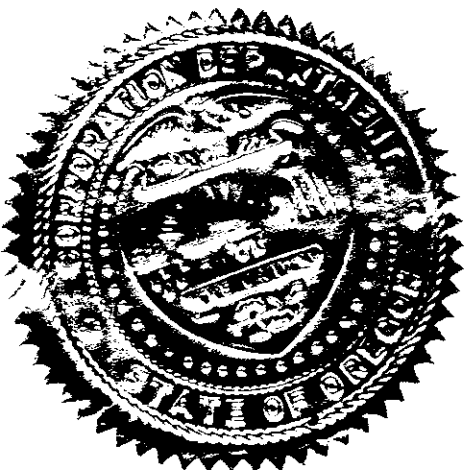

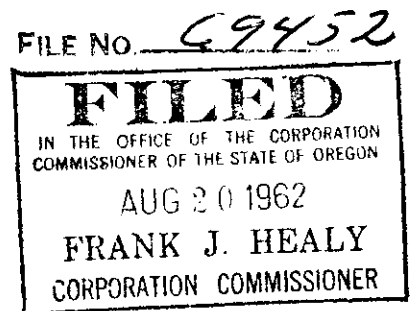

Articles of Incorporation

OF

ONTARIO ASPHALT PAVING COMPANY

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators under the Oregon Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

① The name of this corporation is ONTARIO ASPHALT PAVING COMPANY

and its duration shall be perpetual

ARTICLE II

② The purpose or purposes for which the corporation is organized are:

All lawful activities and general powers granted by law, including, but not limited to the general paving and road construction, subdividing land, all types of construction which in the judgment of the company may be requisite or convenient for its purposes, or incidental thereto, without restriction.

ARTICLE III

③ The aggregate number of shares which the corporation shall have authority to issue is

Fifty Thousand (50,000) shares of the par value of \$1.00 each

ARTICLE IV
