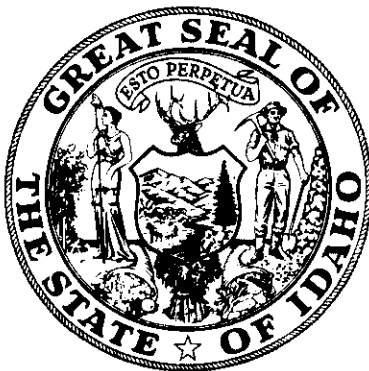

ARTICLES OF INCORPORATION
OF
INTERSTATE FUEL AND FEED, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Interstate Fuel and Feed, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares with a par value of \$5.00 per share for a total authorized capital stock of Five Thousand dollars (\$5,000.00), all of which shall be nonassessable, common stock with equal voting and other rights and privileges.

FIFTH: Provisions denying preemptive rights are: none.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: none.

SEVENTH: The address of the initial registered office of the corporation is 910 Main Street, Suite 232, Boise, Idaho 83702 and the name of its initial registered agent at such address is John R. Rowe, Esq.

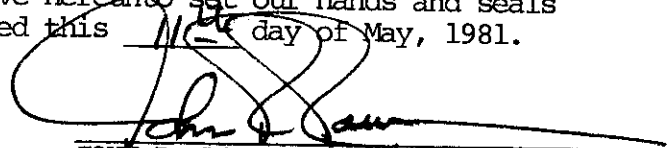

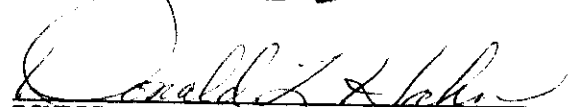
