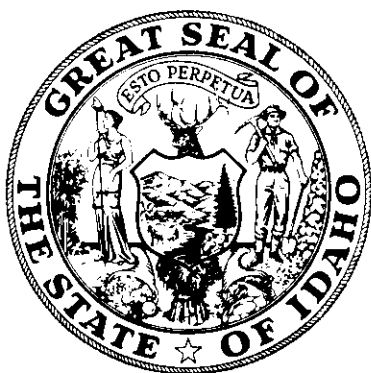

ARTICLES OF INCORPORATION
OF
APACHE INVESTMENT, LTD.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation of such corporation.

FIRST

The name of the corporation is: APACHE INVESTMENT, LTD.

SECOND

The period of its duration is perpetual.

THIRD

The purpose or purposes for which the corporation is organized is to do all acts and exercise all powers, rights and responsibilities available to corporations under the laws of the State of Idaho.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue is three hundred (300) shares at \$3.00 par value per share. There are no restrictions on the trade of stock.

Provisions denying preemptive rights are: none.


