ARTICLE ONE

NAME OF CORPORATION

The period of duration of the corporation shall be perpetual.

AUTHORIZED MEMBERSHIP UNITS

The aggregate number of membership units which the corporation shall have authority to issue shall be fifty (50) shares.

CLASS OF MEMBERSHIP UNITS
