- (c) To act on own account for others. To accomplish any of the foregoing purposes for its own account or as a nominee, agent or trustee for other individuals, partnerships, corporations or other entities.

8. Right of Partners to Receive Distributions.

A partner shall not have the right to receive, nor shall a general partner have the right to make distribution to a partner of all or any of the partner's contribution to capital, except with the unanimous consent of all the partners or upon the dissolution of the partnership.

9. Priorities Among Limited Partners.
