That the purposes for which this corporation is organized are ; to acquire, own and hold water rights, dam and reservoir sites and rightsof-way, and to consturct, maintain and operate on such dam and reservoir sites and rights-of-way, dams, canals, diverting, storage and distributing works for the purpose of providing water for and distributing the same to owners of lands situated under and tributary to such works, to be used in the reclamation and irrigation of such lands and for domestic uses; to divert water from natural streams; to impound water and develop sources of water supply; to establish and operate pumping plants for raising water to a height necessary for use; to utilize water in generating electrical energy for mechanical and illuminating purposes; to construct, maintain and operate, tranmission lines of electrical energy and to the above ends to acquire by purchase, condemnation or otherwise, own, hold, lease, maintain and operate any and all rights, privileges, franchises, dams, and dam sites, reservoir and reservoir sites, canals, flumes head gates, waste gates, distributing gates and ways, pipes and pipe lines, pumps and pumping plants, power plants, machinery, telephone instruments and such other real and personal property as may be necessary

Second.
