MERGER OF SUBSIDIARY ASSOCIATION By

CERTIFICATE OF OWNERSHIP

We, the undersigned, Earl Blaser and Alan C. Jensen, hereby do certify that we are, and at all times herein mentioned have been respectively the President and Secretary of California Canners and Growers, a nonprofit cooperative association organized under the provisions of Chapter 4 of Division 6 of the Agricultural Code of the State of California; and hereby do further certify and state:

- (a) That said nonprofit cooperative association is the sole member of Richmond-Chase Company, a nonprofit cooperative association organized under the provisions of Chapter 4 of Division 6 of the Agricultural Code of the State of California.
- (b) That at a meeting of the Board of Directors of California Canners and Growers the following resolutions were adopted by a majority of its Board of Directors to merge Richmond-Chase Company, a nonprofit cooperative association, and to assume all its obligations:

WHEREAS, this Association is the sole member of Richmond-Chase Company, a nonprofit cooperative association organized under the provisions of Chapter 4 of Division 6 of the Agricultural Code of the State of California; and

WHEREAS, it is deemed advisable and in the best interests of this Association and its members that this Association merge Richmond-Chase Company and assume all its obligations;

NOW, THEREFORE, BE IT RESOLVED, that this Association merge Richmond-Chase Company into itself and assume all its obligations pursuant to California Corporations Code Section 4124;

RESOLVED FURTHER, that the President or Vice President and Secretary or Assistant Secretary be and they hereby are authorized and directed to execute and file a certificate of ownership as required by California Corporations Code Section 4124 and take such further action as may be necessary or proper to accomplish such merger.

(c) That the meeting of the Board of Directors at which said resolutions were adopted was duly held on the 24th day of April, 1963, at the hour of 9:30 o'clock A. M. at the Clift Hotel, 495 Geary Street and Taylor Street, in the City of San Francisco, State of California, and that said resolutions were adopted by the vote of twenty-five directors, the authorized and elected number of directors on the Board being twenty-five, all of whom were present and voting at said meeting.
