ARTICLES OF INCORPORATION

ARTICLE ONE

NAME OF CORPORATION

AUTHORIZED SHARES OF STOCK

The aggregate number of shares of corporate stock which the corporation shall have authority to issue shall be One Thousand (1000) shares. All of such shares of corporate stock shall have a par value of One Dollar (\$1.00) per share.
