

A R T I C L E S O F I N C O R P O R A T I O N .

KNOW ALL MEN:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of incorporating under the laws of the State of Idaho, and in pursuance of the purposes for which we have been elected, as hereinafter set forth, to be known as the VILLAGE IMPROVEMENT SOCIETY of Idaho Falls.

And we certify that the objects for which this corporation is formed are:

To buy, hold and own real estate within the corporate limits of the City of Idaho Falls, as the same are or may hereafter be constituted, for the purpose of establishing thereon parks, drives, lawns, walks and similar improvements for beautifying and making attractive the said City of Idaho Falls, Idaho, for public use and benefit; causing cleanliness of streets and alleys, and other public places or grounds; and to dispose of the property of this corporation when thought advisable so to do to the City of Idaho Falls, provided that two thirds of all the members of this corporation consent thereto.

That the principal place of business of this corporation shall be in the city of Idaho Falls, County of Bingham, State of Idaho.

That the term of the incorporation shall be fifty years.

The number of trustees who shall have the management of its officers shall be five, and the names of the trustees elected for the first year are:

That said Trustees were duly elected at a meeting of the Village Improvement Society of Idaho Falls, duly convened and held at the residence of Mrs. Wm. E. Wheeler, in Idaho Falls, Idaho, on the 2nd day of January, 1904, for the purpose among other things, of electing trustees to take charge and management of its property and affairs, and to form this incorporation. That a majority of said members were then and there present, and voted at said election for the above named trustees as is more particularly set forth in the Certificate of verification by the officers who conducted the election, hereto annexed and made a part of these articles.
