ARTICLES OF INCORPORATION

OF

DONALD GROVE TRUCKING, INC.

SEC. CT.

DONALD GROVE AND LINDA GROVE, each being over the age of 18 years and citizens of the United States of America, hereby make and file these Articles of Incorporation with the purposes of establishing a corporation for the transaction of the business and the promotion and conduct of the objects and purposes herein stated under the laws of the State of Idaho and hereby certify as follows:

ARTICLE I

The name of this corporation (hereinafter referred to as "the corporation") is DONALD GROVE TRUCKING, INC.

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The purpose for which the corporation is organized is the transaction of any lawful business for which corporations may be incorporated under the Idaho Business Corporation Act and generally to carry on any business and have all powers conferred by the State of Idaho upon a corporation formed under its laws and specifically, but not by limitation, to conduct logging activities, including logging transportation.

ARTICLE IV

The corporation shall have the authority to issue 100 shares of common stock with no par value, which shall qualify as \$1244 stock, Internal Revenue Code. All of said stock shall be voting common stock of one single class having equal rights, powers and preferences.

ARTICLE V

The incorporators of the corporation are DONALD GROVE AND LINDA GROVE, HCR 01, Box 297, Naples, Idaho 83847.

ARTICLE VI

The initial registered office of the corporation shall be HCR 01, Box 297, Naples, Idaho 83847, and the initial registered agent at said address is DONALD GROVE.

ARTICLE VII

The number of directors constituting the initial board of directors shall be two (2). The names and address of the initial directors who will serve as directors until the first annual meeting of shareholders or until their successors are elected and qualified are DONALD GROVE AND LINDA GROVE, HCR 01, Box 297, Naples, Idaho 83847.

ARTICLE VIII

The officers of the corporation shall be a president, a treasurer and a secretary. All of said officers shall be elected by the board of directors and shall hold office and have the powers as respectively specified in the corporate bylaws.

ARTICLE IX

Subject to the power of the shareholders to amend or repeal the bylaws, the board of directors shall have the authority to amend the bylaws, define the powers and duties of the corporate officers and provide for such other matters as they deem essential or convenient to the conduct of the corporation's affairs, insofar as said authority is consistent with the laws of the State of Idaho and these Articles of Incorporation.
