ARTICLES OF INCORPORATION  
of  
LAKESHORE EQUIPMENT RENTALS, INC.

We, the undersigned, being natural persons of the age of twenty-one years or more, and subscribers to the shares of the corporation to be organized pursuant hereto, and all citizens of the United States, have this day voluntarily associated ourselves together for the purposes of forming a private corporation under the laws of the State of Idaho and to that end hereby adopt the following Articles of Incorporation:

I.

The name of the proposed corporation is:

LAKESHORE EQUIPMENT RENTALS, INC.

II.

The purposes of said corporation are:

The corporation shall have all of those powers enumerated and set forth in 30-114 Idaho Code, as are statutorily granted to corporations organized and existing under and by virtue of the laws of the State of Idaho.

The corporation shall have the right to buy, purchase, own and acquire stock in this corporation or other corporations.

The corporation shall be authorized and entitled to borrow money, give security therefor, and undertake such contracts and agreements for the purchase and sale of real and/or personal properties as may be reasonably required to

carry out the general purposes of this corporation.

The corporation shall be authorized and empowered to conduct and carry on the business of renting and leasing scaffolding, barricades, warning signs, equipment, hand tools and equipment connected with the business of construction, including design, enlarging, extending, repairing, completing, removing or otherwise engaging in any work on a commercial, industrial or residential structure using any building material and technique now employed or to be developed; to otherwise acquire and furnish by renting and/or leasing all materials, tools and equipment connected therewith or required for the prosecution of all contract agreements to generally carry forth the business of construction, excavation, and/or road work, road materials and any and all incidents related thereto.

### III.

The duration of this corporation shall be perpetual.

### IV.

The total authorized number of par value shares of this corporation is 500; the aggregate par value of the

total authorized number of par value shares is \$5,000.00. The shares hereunder shall be common stock and shall be non-assessable. The total authorized capital of said corporation shall be the sum of \$5,000.00.

VI.

The By-Laws of the corporation shall have the right to restrict the number of shareholders of this corporation in number and to further restrict transfer of stock by the corporation so that violation of the number of shareholders authorized to exist by the corporation shall not be in jeopardy.

VII.

The total number of shareholders authorized to exist under and by virtue of this corporation shall not exceed the number of ten (10) and this corporation is organized under and pursuant to the provisions of a Sub Chapter "S" Corporation pursuant to and in accordance with the statutes and rules and regulations of the United States of America pertaining or applicable thereto.

VIII.

Pursuant to that statutory authority granted by 30-132(7) Idaho Code, the Directors of the corporation do have the power to repeal, amend and adopt new By-Laws for and on behalf of the Corporation by a two-thirds (2/3) vote of the Board of Directors.

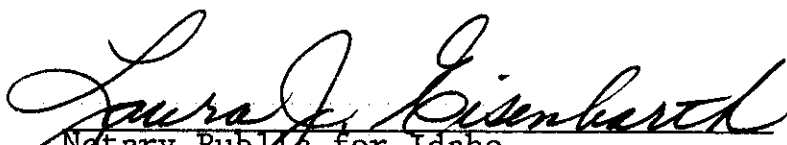

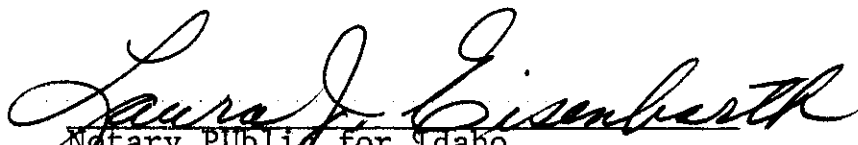
