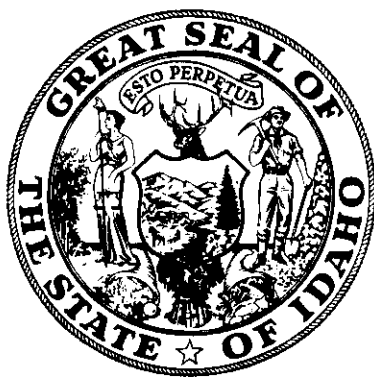

ARTICLES OF INCORPORATION

19 JUN 19 1961

I.

I, the undersigned, being a natural person of full age, and a citizen of the United States, or of its territories or possessions, do hereby voluntarily form a private corporation, under the laws of the STATE OF IDAHO.

II.

The name of the proposed corporation is LEWIS & CLARK INVESTMENT ENTERPRISES, INC.

III.

The period of it's duration is perpetual.

IV.

The location and address of the registered office of this corporation shall be 105 South 8th, St. Maries, Idaho 83861.

V.

VI.

The purpose of the corporation is the transaction of any or all lawful business for which corporations may be incorporated under this act.

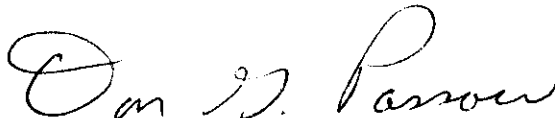

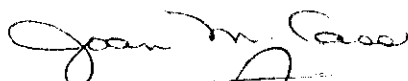
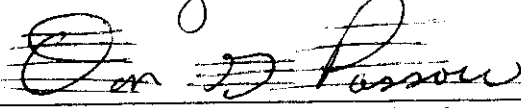
