ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS, THAT WE, THE UNDERSIGNED, BEING NATURAL PERSONS OVER THE AGE OF EIGHTEEN (18) YEARS, DO HEREBY FORM A GENERAL BUSINESS CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO AS CONTAINED IN TITLE 30 OF THE IDAHO CODE ENTITLED "GENERAL BUSINESS CORPORATION ACT", AND TO THAT END DO HEREBY SET FORTH AS FOLLOWS:

1. THE NAME OF THE CORPORATION IS: DATA SOLUTIONS, INC.

2. THE PERIOD OF DURATION OF THIS CORPORATION SHALL BE PERPETUAL.

3. THE PURPOSES FOR WHICH THIS CORPORATION IS ORGANIZED:

(A) PRIMARILY TO OPERATE A RETAIL BUSINESS.

(B) THE TRANSACTION OF ANY OR ALL LAWFUL BUSINESS FOR WHICH CORPORATIONS MAY BE INCORPORATED UNDER THE IDAHO BUSINESS CORPORATION ACT.

4. THE COUNTY IN THE STATE OF IDAHO WHERE THE PRINCIPAL OFFICE FOR THE TRANSACTION OF BUSINESS OF THE CORPORATION IS LOCATED IS IN THE COUNTY OF BANNOCK AND THE NAME OF THE REGISTERED AGENT IS LARRY DAVID CHRISTENSEN, AND THE ADDRESS OF THE REGISTERED OFFICE SHALL BE 232 SKYLINE DR., POCA TELLO, IDAHO 83204.

5. THE AGGREGATE NUMBER OF SHARES WHICH THE CORPORATION SHALL HAVE AUTHORITY TO ISSUE IS 100,000 HAVING A PAR VALUE OF \$1.00 PER SHARE. ALL OF SAID STOCK SHALL BE KNOWN AS COMMON STOCK AND SHALL BE NONASSESSABLE.

SUBSCRIBE FOR OR PURCHASE ANY OF SUCH ADDITIONAL SHARES OF STOCK.


8. THE NUMBER OF DIRECTORS OF THE CORPORATION MAY BE FIXED BY
