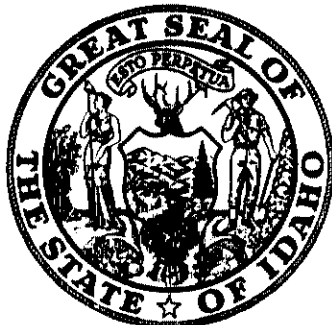
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

The undersigned, being natural persons of full age, citizens of the United States of America and residents of the State of Idaho, acting as incorporators of a corporation under the Idaho Business Corporation Act, have voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and do hereby and herein adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is G & G APPLIANCE SERVICE, INC.

ARTICLE II

The purposes for which the corporation is organized are:

1. To provide appliance repair and service.
2. To buy inventory for resale.
3. To apply for, receive and hold all licenses that may be necessary or required from any licensing agency, Federal, State, municipal or foreign, for conducting any business in which the corporation may hereafter be engaged.

ARTICLE IV

The total authorized shares which the corporation shall have authority to issue is One Hundred (100) shares having a Par Value of None. All or any part of said shares may be issued by the Corporation from time to time and for such consideration as may be determined upon or fixed by the Board of Directors, as provided by law.

ARTICLE V
