ARTICLES OF INCORPORATION

OF

NELSON--DEPPE, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, G. S. NELSON, DEMOND DEPPE, and ROSALIE E. LEONARD, all of whom are natural persons, and citizens of the United States of America, over the age of twenty-one years, have this day voluntarily associated ourselves together for the purpose of forming a private corporation under the laws of the State of Idaho, and we hereby adopt the following Articles of Incorporation:

ARTICLE I. --NAME. The name of this corporation is and shall be, NELSON--DEPPE, INC.

ARTICLE II. --TERM. The term of this corporation shall be perpetual.

ARTICLE III. --REGISTERED OFFICE. The location and post office address of the registered office of this corporation in this state is Nampa, Canyon County, State of Idaho.

ARTICLE IV. --PURPOSES. The purposes for which this corporation is formed are:

To conduct and carry on the business of general contractors and builders; to conduct and carry on the business of general manufacturers; to conduct and carry on said businesses of general contractors and builders and general manufacturers, or either or any of them, alone or with others as co-partners or joint adventurers, or otherwise; to perform labor upon and to furnish materials to be used in the construction, alteration or repair of any structure, or work or works; to repair personal property of every kind and nature, and to furnish labor and material to be used in the manufacture, alteration and repair of such personal property.

To acquire, hold, use, sell, assign, lease, grant license in respect of, mortgage, or otherwise dispose of letters patent of the United States or any foreign country, patent rights, licenses and privileges, inventions, improvements,

and processes, copyrights, trademarks and trade names, relating to or useful in connection with any business of this corporation.

To acquire and pay for in cash, stock or bonds of this corporation, or otherwise, the good will, rights, assets and property, and to undertake or assume the whole or any part of the obligations or liabilities of any person, firm, association, or corporation.

To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of shares of the capital stock of, or any bonds, securities, or evidence of indebtedness created by any other corporation or corporations organized under the laws of this state, or any other state, country, nation, or government, and while the owner thereof to exercise all the rights, powers, and privileges of ownership.

To issue bonds, debentures, or obligations of this corporation from time to time, for any of the objects or purposes of the corporation, and to secure the same by mortgage, pledge, deed of trust, or otherwise.

To purchase, hold, sell, and transfer the shares of its own capital stock; provided it shall not use its funds or property for the purchase of its own shares of capital stock when such use would cause any impairment of its capital; and provided further that the shares of its own capital stock belonging to it shall not be voted upon directly or indirectly.

To have one or more offices, to carry on all or any of its operations and business and without restriction or limit as to amount to purchase, or otherwise acquire, hold, own, mortgage, sell, convey or otherwise dispose of real and personal property of every class and description in any of the States, Districts, Territories or Colonies of the United States, and in any and all foreign countries, subject to the laws of such State, District, Territory, Colony or Country.

In general, to carry on any other business in connection with the foregoing, and to have and exercise all the powers conferred by the Business Corporation Act of the State of Idaho, and to do any or all of the things hereinbefore set forth to the same extent as natural persons might or could do.

The foregoing clauses shall be construed both as objects and powers; and it is hereby expressly provided that the foregoing enumeration of the specific powers shall not be held to limit or restrict in any manner the powers of this corporation.

ARTICLE V. --AUTHORIZED SHARES: The total authorized number of shares of this corporation shall be Five Thousand (5,000) shares of ^{non-assessable} common stock of a par value of One Hundred Dollars (\$100.00) per share, and with an aggregate par value of Five Hundred Thousand Dollars (\$500,000.00).

ARTICLE VI. --DIRECTORS: The number of directors shall be three, until otherwise prescribed by the By-Laws of this corporation. Said directors may, but need not be, stockholders of this corporation.

ARTICLE VII. --INCORPORATORS: The name and post office address of each of the incorporators, and the number of shares subscribed by each, is as follows:

ARTICLE VIII --BY-LAWS: The power to repeal and amend, and to adopt new By-Laws, hereby is conferred upon the directors of this corporation.




