The undersigned, a natural adult person, does hereby submit the following for the purpose of forming a Wyoming corporation under the WYOMING BUSINESS CORPORATION ACT.

I.

The name of the corporation is KENYON TRUCKING, INC.

II.

The period of the corporation's existence is perpetual.

III.

The corporation shall have unlimited power to engage in and do any lawful act concerning any or all lawful businesses for which corporations may be organized under this act.

IV.

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of common stock having no par value.
