

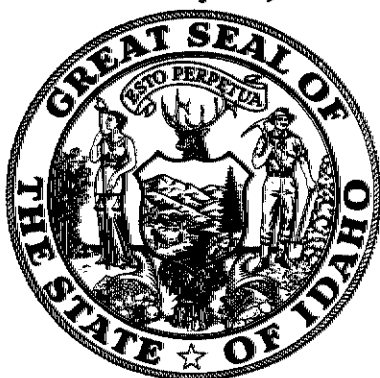
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

HUDD NO. III, INC.

KNOW ALL MEN BY THESE PRESENT:

We the undersigned, have voluntarily associated ourselves together for the purpose of forming a corporation under the Laws of the State of Idaho, relating to private corporations: and to that end. do hereby adopt these Articles of Incorporation; as follows:

ARTICLE ONE: The name of this Corporation shall be HUDD NO. III, INC.; an Idaho Corporation

ARTICLE TWO: This Corporation shall have perpetual existence.

ARTICLE THREE: The nature of business, objects and purposes to be transacted, promoted or otherwise engaged in by this corporation is any lawful business activity or enterprise, within or without the State of Idaho or within or without the United States of America.

ARTICLE FOUR: This corporation is authorized to issue only one class of stock which shall be designated as capital stock. The total number of shares of capital stock that this corporation is authorized to issue is TWENTY FIVE THOUSAND SHARES (25,000) with a par value of FIVE DOLLARS PER SHARE (\$5.00).

ARTICLE FIVE: NO preemptive right shall exist.

(a) Holders of any shares that is limited as to assets or dividends, shall not be entitled to any preemptive rights.

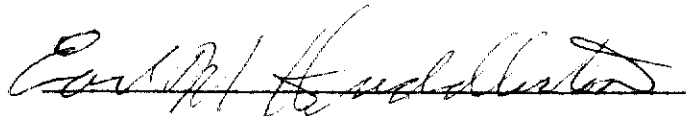
