(NON-PROFIT)

The undersigned, in order to form a Non-profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

### ARTICLE 1 NAME

The name of this corporation shall be the Prairie Quick Response unit Inc.

### ARTICLE 11 PURPOSE

The purpose of this corporation shall be to provide emergence care for the ill and injured persons and to perform rescue-extrication when necessary, within the geographic limits for response as defined by the Chief of the Emergency Medical Services (EMS) Bureau.
