ARTICLE I: NAME

The name of the non-profit corporation shall be the Citizens Organization for Police Support, Inc. (COPS).

## ARTICLE II: PURPOSE

A public relations committee to foster a positive image of the IFPD to the community.

A compassionate service committee to render aid to police officers or their families if police officers are injured or killed in the line of duty.

Any other committee established by the Board of Directors that fulfills the objectives of COPS

Any of such assets not so distributed shall be disposed of by the District Court of Bonneville County, Idaho exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purpose.
