

The undersigned, acting as President and Secretary-Treasurer of the above-named corporation, are hereby adopt the following Articles of Amendment for such corporation:

- 1. The name of this corporation is Ririe Producers Cooperative, Inc.
- 2. This Amendment is to amend Article IV of the original Articles of Incorporation to delete Article IV as it now reads and to substitute the following:

ARTICLE IV

The corporation (association) shall have perpetual existence.

- 3. Said amendment was adopted by the directors of the corporation at a special directors meeting held February 9, 1995. Thereafter, it was presented to the members at a special membership meeting on March 30, 1995.
- 4. On that date, there were 216 memberships outstanding with each member entitled to one vote. There was and is no classification of memberships. There were 37 members present, and all of them voted in favor of the amendment. There was no opposing vote.
