To the Secretary of State of the State of Idaho  
Pursuant to Title 30, Chapter 3, Idaho Code, the undersigned  
non-profit corporation amends its articles of incorporation as  
follows:

1. The name of the corporation is:  
Greenscool Incorporated

If the corporation has been administratively dissolved and the corporate name is no longer  
available for use, the amendment(s) below must include a change of corporate name.

2. The text of each amendment is as follows:

Article 2: The purpose for which the corporation is organized is: Education. This organization is organized  
exclusively for charitable purpose within the meaning of section 501(c)(3) of the Internal Revenue Code.  
Notwithstanding any other provision of these Articles, the organization shall not carry on any other activities  
not permitted to be carried on by an organization exempt from Federal income tax as an organization  
described in section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal  
tax code.

Upon the dissolution and winding up of this organization, after paying or adequately providing for the debts  
and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation or  
corporation organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal  
Revenue Code and which has established its tax-exempt status under that section.
