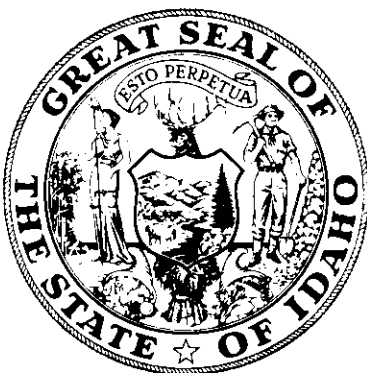


The undersigned, the duly elected president and secretary of H. H. Consultants, Inc., adopt the following Articles of Dissolution for the corporation:
