5 KNOW ALL MEN BY THESE PRESENTS: That the stockholders of
6 Payette Livestock Co., an Idaho corporation, have by legal and
7 proper resolution of amendments, adopted at a legally called and
8 held meeting of the stockholders on the 14th day of June, 1971,
9 notice of which said meeting was duly and legally waived in strict
10 conformity with the laws of the State of Idaho, and the By-Laws
11 of the corporation, amended the Articles of Incorporation of the


