ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That the stockholders of Payette Livestock Co., an Idaho corporation, have by legal and proper resolution of amendments, adopted at a legally called and held meeting of the stockholders on the 14th day of June, 1971, notice of which said meeting was duly and legally waived in strict conformity with the laws of the State of Idaho, and the By-Laws of the corporation, amended the Articles of Incorporation of the Payette Livestock Co., as follows, to-wit:
